# Duties, Liabilities, General Provisions

The provisions outlined below shall apply for the consulting services agreed upon in this contract.

## Cancellation, Cancellation Fee

For cancellations of fixed project appointments caused by the client with a lead time of less than five working days, the client pays 100% of the agreed fees as cancellation fee if the contractor cannot use the initially allocated time economically in other ways. In particular, this concerns the documents required to carry out the audit and to prepare the audit report. The client undertakes to present the existing circumstances truthfully and in their entirety.

## Contradictions of GTC/ Purchase Conditions

The contractor herewith objects to any counter-confirmation with regard to the client's own General Terms and Conditions or Purchase Conditions. Individual agreements between the parties remain unaffected.

## General Information

All contractual relations are governed by German law under exclusion of the United Nations Conventions on Contracts for the International Sale of Goods (CISG). The exclusive place of jurisdiction is Frankfurt am Main in the Federal Republic of Germany, provided the client is a merchant (as defined by the German Civil Code). The contractor is entitled to also take legal action at the user's general place of jurisdiction. In case of doubt, the German contract text of this offer and its individual provisions take precedence over any translated versions. If one or several provisions of this agreement become invalid, the remaining provisions of this agreement remain unaffected.
