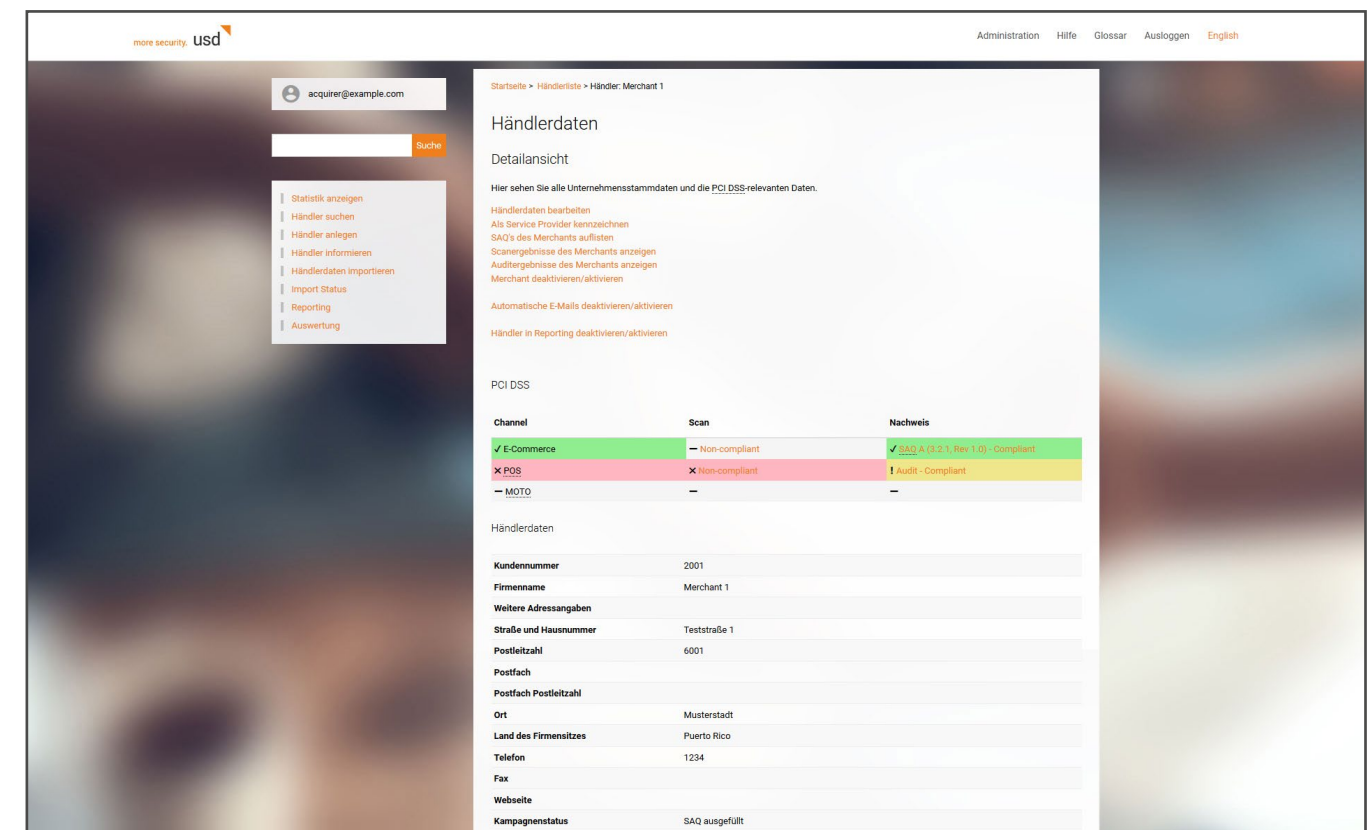

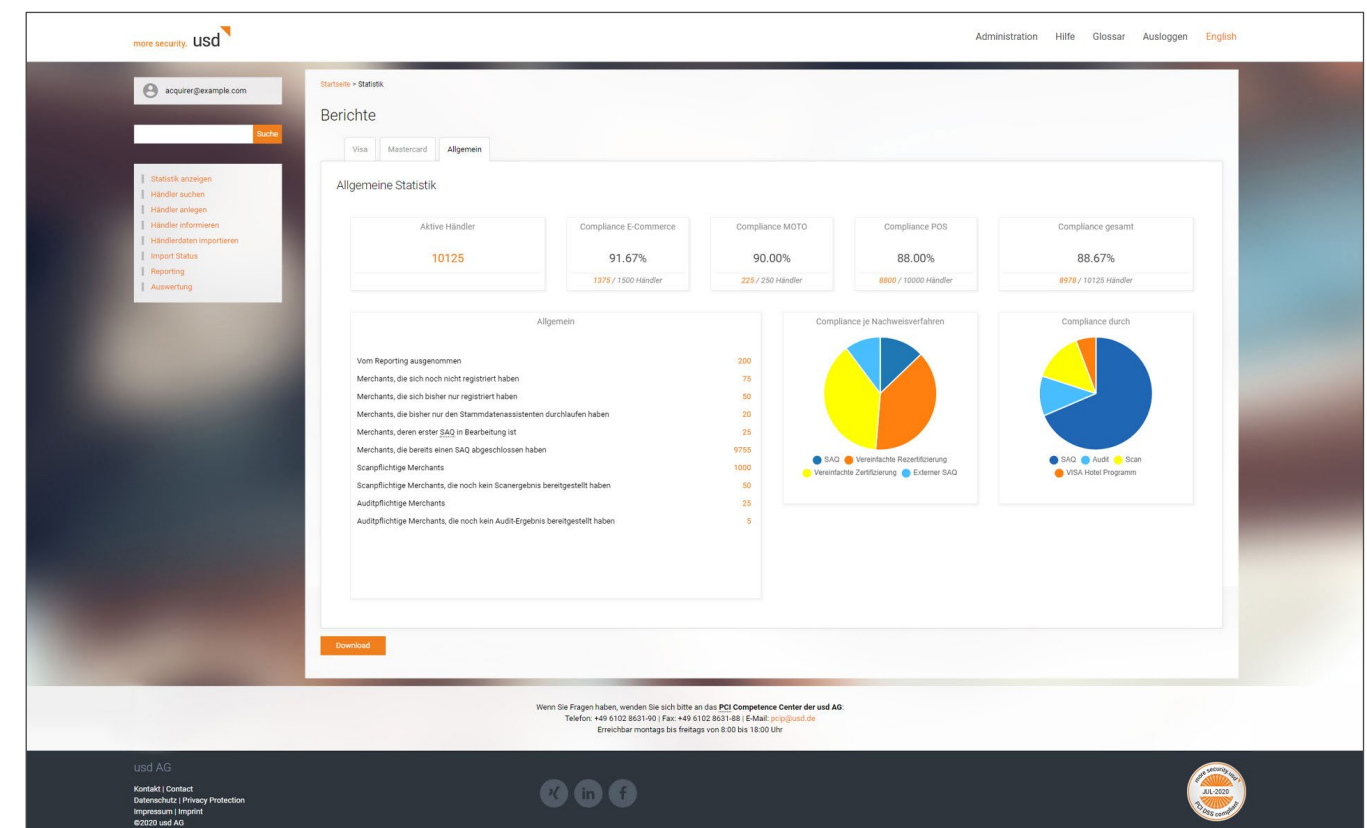

Merchant compliance view

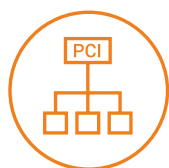


Scheme statistics and compliance overview

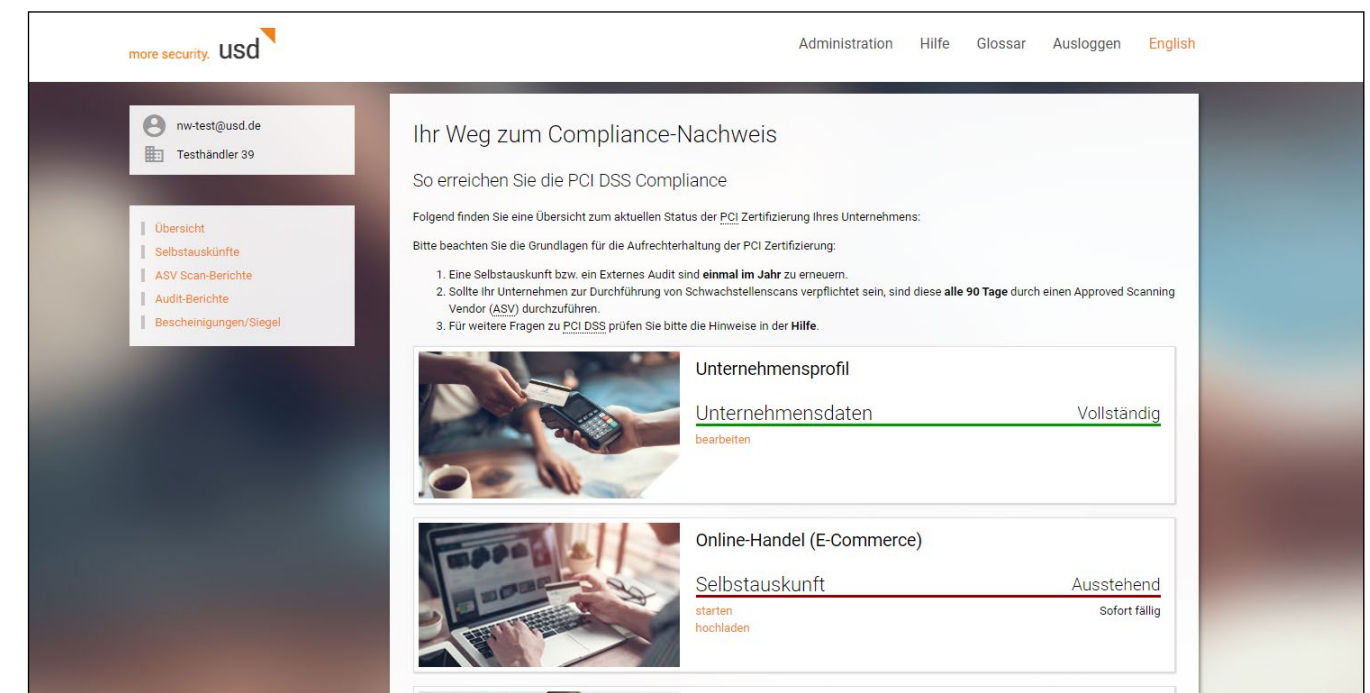

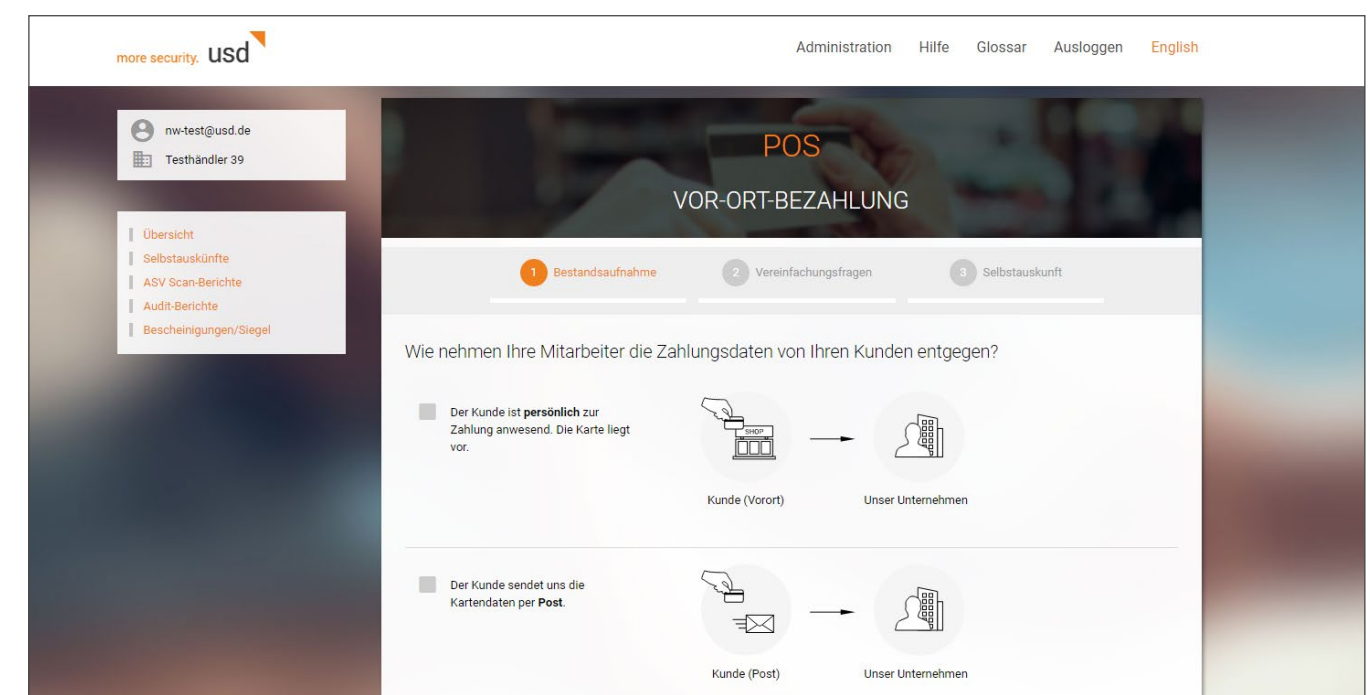

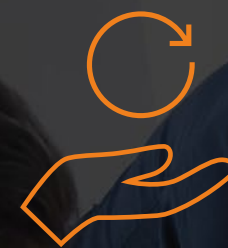
