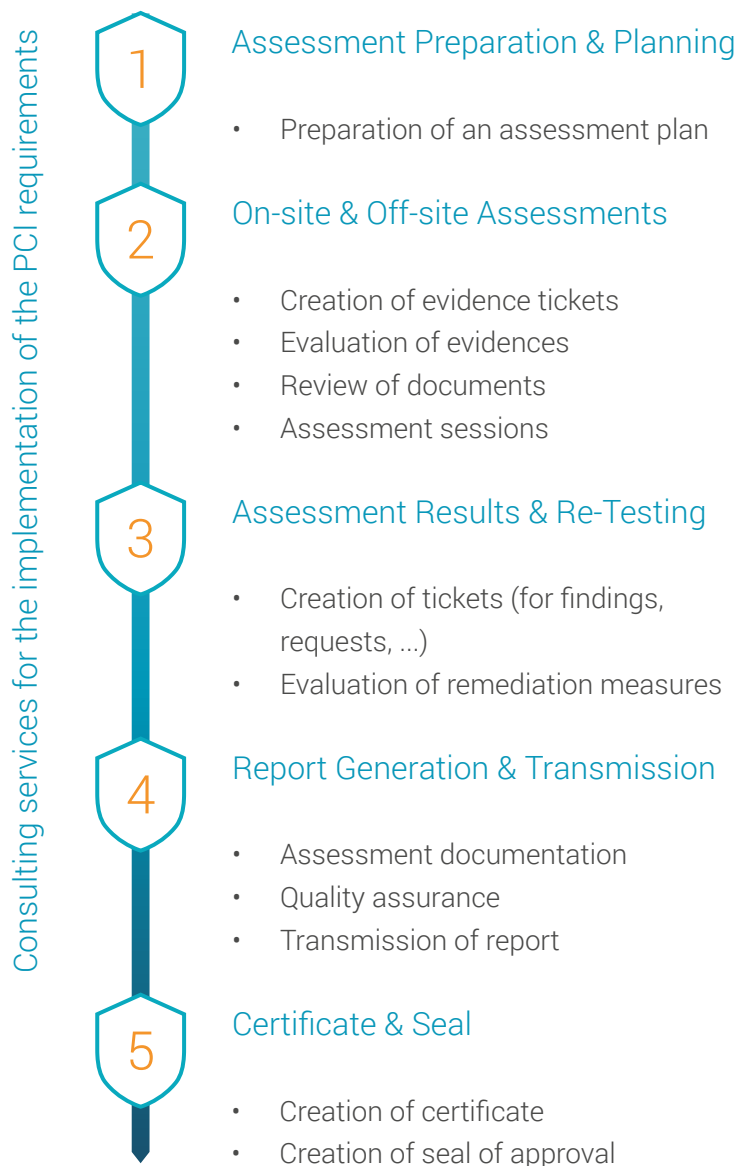

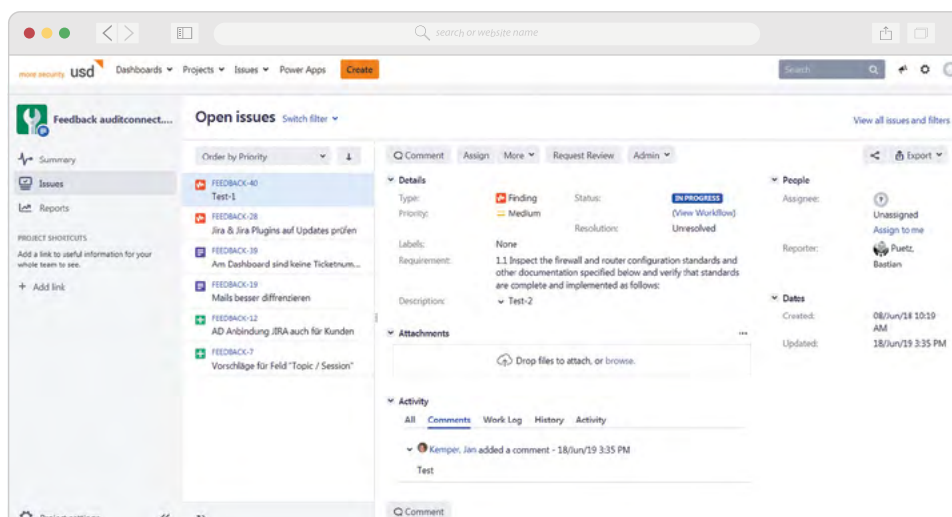

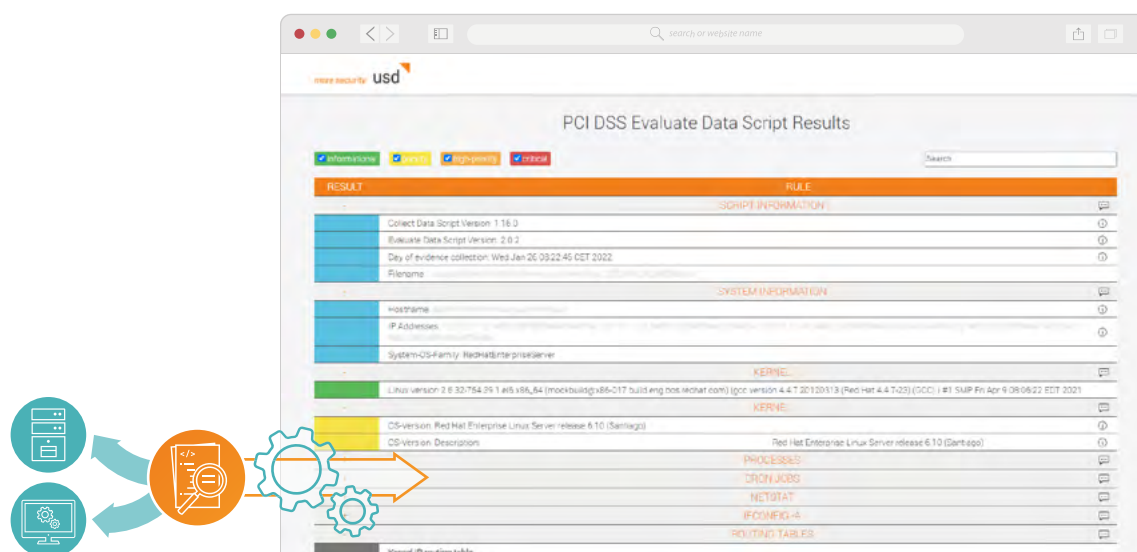
Transparent Interaction during the Assessment

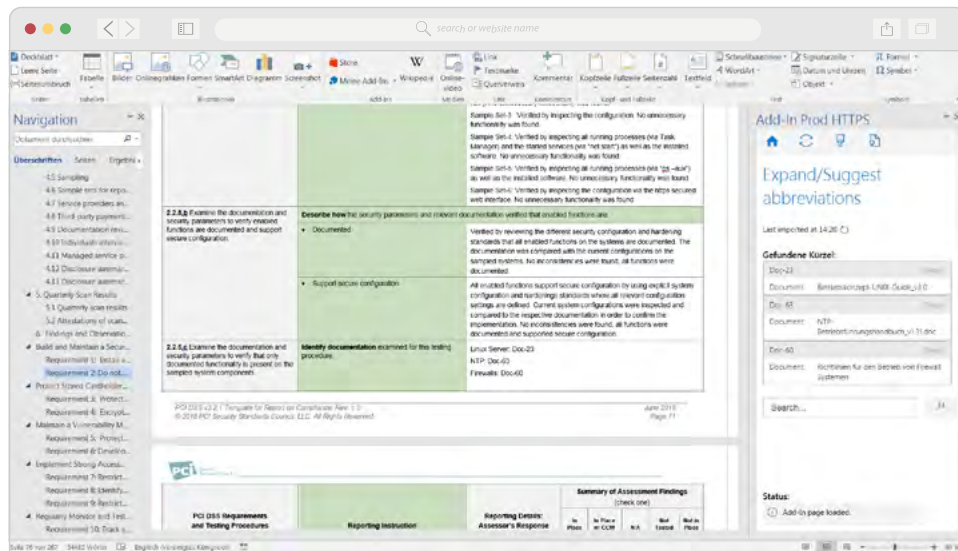
